

- 1 This competition is conducted by Kidzcationz Pty Limited t/a Petcationz ABN 44606248524 (referred to as “we”, “us” or “our”), and the individual or entity (referred to as “you” or “your”).
- 2 These terms and conditions, together with the entry form, govern the competition and are intended to be a legally binding agreement. Entry into this competition is deemed acceptance of these conditions of entry. For the purposes of Australian law, this colouring-in contest is a ‘game of skill’ and chance plays no part in determining the finalists or winners.
- 3 Participation is open to any person who is not a director or employee (or the immediate family member of a director or employee) of Kidzcationz Pty Limited or any of its related bodies corporate and not the winners of a previous competition (eligible participant). We reserve the right to confirm and verify an entrants age by requesting proof in writing. The competition is not open to entries of work authored by individuals who are deceased at the time of judging.
- 4 The competition commences at 9am AEST on 7 July 2016 and concludes at 5pm AEST on Sunday 31 July, 2016. Any entry deemed incomprehensible by the Judging Panel (as defined below) will be invalid.
- 5 Eligible participants are invited to submit the completed colouring-in age downloadable in PDF format for colouring in the “Welcome To My Websites” Competition 2016 on petcationz.com.
- 6 Any colouring media is acceptable.
- 7 Eligible participants may submit one entry only.
- 8 Each entry must be submitted electronically via the competition web page.

- 9 Entries submitted via channels other than by the competition web page cannot be attributed to the author properly, and therefore will not be considered eligible for the contest.
- 10 Entries received by us will be judged by a judging panel consisting of at least three of the Kidzcationz Pty Limited staff.
- 11 The maximum file size for upload will be limited to 6 MB (megabytes).
- 12 Judging will take place on 1 & 2 August 2016. The eligible entry that is selected by the Judging Panel as the top entry of the petcationz.com “Welcome To My Websites” Competition 2016, will be announced on Friday 5 August 2016 via email to the winner and on the petcationz.com website, Facebook, Twitter and Instagram pages.
- 13 All our decisions and those of the Judging Panel are final. We and the Judging Panel will not enter into any discussions or correspondence regarding any decision in relation to the final decision. No feedback will be provided on unsuccessful entries.
- 14 By submitting a page and taking part in the competition, each entrant agrees that (1) the page they have submitted may be published from time to time, free of charge, on our and affiliate websites, if the Judging Panel selects the page as a finalist; and (2) the page is the entrant’s original work and does not infringe the intellectual property rights of any other person or entity. The winners will be duly attributed as the author of the entry in any publication.
- 15 By submitting the page and taking part in the competition, the winners thereby grant to us a non-exclusive, perpetual, irrevocable, royalty-free license to use, reproduce, publish, adapt and communicate the page anywhere in the world. The winners acknowledge and agree that we are free to use the page and to exercise its rights in relation thereto. The

winners agree to execute any documentation required to give effect to our rights under this clause, including any required moral rights waivers.

- 16 The winners will be notified on a confidential basis by email prior to the public announcement of the winners. The winners must keep confidential the fact that their page has been selected as the winning entry until the public announcement.
- 17 We reserve the right to confirm and verify the identity of the winners, by requesting the person(s) to provide proof of age, proof of identity, proof of residency and proof that they submitted the photo. Identification considered suitable for verification is at our absolute discretion.
- 18 All 3 winners (overall winner and 2 other category winners) will have their page featured on petcationz.com and on social media after competition of the competition. Winners will individually win a prize consisting of a Hard Copy the book “Jed Finds His Forever Home” signed and dedicated to the winner by the Author Bella Tipping.
- 19 A prize may not be transferred and must be accepted as awarded. A winner may not request cash or a substitute prize; however we reserve the right to substitute a prize with another prize of equal or greater value if the prize is not available for any reason.
- 20 The winners may be invited by us to participate in a media campaign (as determined by us), including but not limited to, being interviewed and photographed, filmed and having their name and photograph published in any publications at our absolute discretion. By submitting an entry, eligible participants agree that if the Judging Panel selects their page as a winner, they will participate in and co-operate as required with all reasonable media editorial requests made by us at no cost to the finalists or winners. We are not obliged to invite the finalists

to participate in any such media campaign and the invitation is at our absolute discretion.

- 21 If we do not receive a page that meets the expected artistic standard in a category as determined by the Judging Panel, we are not obliged to select any finalists or winners.
- 22 We accept no responsibility for lost, late, incomplete, incorrectly submitted or misdirected entries, including entries not received by us or delays in the delivery of a page due to technical disruptions, network congestion or for any other reason.
- 23 If an eligible participant's contact details change during the period of the competition, it is the eligible participant's responsibility to notify us. A request to access, modify or delete any information provided in an entry form should be directed to us. No changes may be made to a page after submission.
- 24 We respect an individual's right to privacy and that individual's right to control how information held on their behalf is used. Personal information collected by us, from you, will be used to keep you up to date with our work by disseminating information via email, mail, SMS or telephone. This may include newsletters, appeals or other information. Please contact us should you wish to alter or delete any of these methods of contact. - 25 If the competition is not capable of running as planned for any reason outside of our control including (without limitation) vandalism, power failures, tempests, natural disasters, acts of God, civil unrest, strike, war, act of terrorism; or due to infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any

cause which corrupts or affects the administration, security, fairness or integrity or proper conduct of the competition, we reserve the right in its sole discretion to take any action that may be available including to cancel, terminate, modify or suspend the competition, subject to any written directions given from the various State or Territory Government authorities (where required) or New Zealand.

26 We and our related bodies corporate will not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss), or for any personal injury suffered or sustained in connection with this competition except for any liability which cannot be excluded by law. Other than statutory and other warranties that cannot be excluded by law, we and our related bodies corporate assume no responsibility for any incorrect or inaccurate information, either caused by an entrant or as a result of any of the systems, equipment or programming associated with or utilised in this competition, or for any technical or human error, or any combination thereof that may occur in the course of the administration of this competition including any omission, interruption, deletion, defect, delay in operation or transmission, communications line, computer line, mobile telephone or satellite network failure, software, server or provider failure, theft or destruction or unauthorised access to or alteration of entries, and reserves the right to take any action that may be available.
